Concession at Crane? Should we downsize the menu? Would that make it easier to manage? We need better communication with the Managers in the spring for their duties for getting volunteers in the concession.

Postponed discussion from previous meeting: Registration fees for Spring Ball. Last year it was \$95.

Discount period for registration is Nov. 1 – Dec. 17. After that the price goes up \$25 a player. After Jan. 7, the full amount will be in effect: \$145. So, there is a \$20 discount each period before the final wave of registration. T-Ball and Machine Pitch BB and Coach Pitch SB will pay \$20 less each registration period.

Registration date: We will offer 2 more registration dates in January in addition to those agreed to last week.
